3.6 The Prices should be quoted in Indian Rupees only.

- 4. Each bidder shall submit only one quotation.
- 5. Quotation shall remain valid for a period not less than **55** days after the last date of quotation submission.
- 6. Evaluation of Quotations,

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

6.1 are properly signed ; and

6.2 confirm to the terms and conditions, and specifications.

- 7. The Quotations would be evaluated for all items together.
- 8. Award of contract:

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- 8.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 8.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
- 9. Payment shall be made in Indian Rupees as follows:

Delivery and Installation - 90% of total cost

Satisfactory Acceptance - 10% of total cost

- 10. All supplied items are under warranty of **24** months from the date of successful acceptance of items.
- 11. You are requested to provide your offer latest by 16:00 hours on 10-Nov-2018.
- 12. Detailed specifications of the items are at Annexure I.

- 15. Information brochures/ Product catalogue, if any must be accompanied with the quotation clearly indicating the model quoted for.
- 16. Sealed quotation to be submitted/ delivered at the address mentioned below, Govt. College of Engineering & Technology, Chak Bhalwal, Jammu.

- 18. The offer/bid should be submitted in two bid systems (i.e.) Technical bid and Financial bid. The technical bid should consist of all technical details along with commercial terms and conditions and relevant literature, if any. Financial bid should indicate item wise price for the items mentioned in the technical bid.
- 19. The Technical bid should be sealed in envelope "A" mentioning Technical bid on top of the envelope and Financial bid in envelope "B" mentioning Financial bid on the top of the envelope. Both the envelopes should be packed in a single envelope.
- 20. All the envelopes should mentioned the shopping number.
- 21. The technical bid will be opened first and it will be examined by a technical committee (as per specification and requirement mentioned in the NIQ). The financial offer/bid will be opened only for the offer/bid which technically meets all requirements as per the specification, and will be opened subsequently for further evaluation.
